ENTRY RULES

All entry fees are non refundable. Artists may enter up to three pieces. Diptychs and triptychs are counted as multiple works unless they are matted and framed together and meet the size limitations. No works will be considered for show unless payment is made in full with entry. Brandon Gallery reserves the right to decline any entries that do not meet the criteria, standards or quality level of the exhibition.

ENTRY FEES

- 1 entry \$20
 - 2 entries \$30
 - 3 entries \$40
- CHECK OR CASH ONLY** – Check payable to Brandon Gallery at time of entry. No refund on declined work

SALES

Brandon Gallery will retain 30% of sales. No work may be withdrawn before close of show.

PRESENTATION OF ART

All media accepted. Works must be no larger than 14 ½ inches on any side, including frame. Wire hangers only with ends wrapped for safety. No sawtooth hangers. 3D work not to exceed size limitations and under 20 lbs. Each piece should have on the back, artist name, contact information and title of piece.

DELIVERY FOR JURY PROCESS

Art must be delivered to Brandon Gallery on Friday, October 20 or Saturday 21, 11am to 3pm along with a completed entry form.
